

1. Access to flights is strictly forbidden during the closing hours of the facility and, in any case, in the absence of the assigned staff.

2. By purchasing tickets which entitle holders to access to flights, users acknowledge that they have read, understood and **unconditionally accepted this regulation** and declare that they are mentally and physically capable of taking part in the flight in total safety and in control of their conduct; for minors, the purchase of the ticket is completed by the adult exercising parental authority or by the accompanying guardian. With the purchase of the ticket, the adult guarantees that the minor is mentally and physically able to practice flying in complete safety and control of his/her conduct. In the same way, the accompanying person of persons and/or groups with disability also declares the same assurances when purchasing tickets for persons and/or groups with disability.

4. The price of the ticket includes:

- the uphill lift with the dell'Angelo chairlift
- the use of equipment consisting of full harness, chairlift, lanyards and carabiners, pulley, and helmet;
- the theoretical and practical briefing for the safe use of the equipment, which will be carried out before the flight by the staff in charge;
- if necessary, the assistance and support of the "Zipline dell'Angelo" staff during the flight itinerary;
- the flight itinerary.

5. Access to the flight itinerary is only permitted after the instruction briefing. With access to the flight itinerary, **users acknowledge that they have understood the activity** on offer, that they have no doubts as to how to conduct themselves, that they have the technical and physical capabilities to safely complete the flight itinerary, and that they undertake to conduct themselves in a manner respectful of the instructions received.

6. Each individual user descends the itinerary independently, aware of the activity he or she is performing, under his or her own responsibility, acknowledging that his or her physical and technical capabilities are adequate. If there are any doubts and/or fears, users are required to notify the staff before departure in order to receive the necessary assistance. PromoTurismoFVG accepts no liability in the event of an accident caused by negligence or carelessness on the part of the user or failure to comply with the rules and safety instructions given.

7. It is compulsory to follow instructions, including any instructions given by the "Zipline dell'Angelo" staff during the activity.

8. The flight itinerary is composed of a span with 2 independent lines where each line can only be travelled by one single user at a time, or it can be travelled at the same time with simultaneous departure, but each user on his or her own zipline. At the departure station (upslope), only the users who are scheduled to make the flight are allowed to be present and, in any case, take directions from the staff in attendance. On reaching the arrival station (valley), users are required to follow the instructions of the staff on duty.

9. In the unlikely event, however possible, of a possible stoppage occurring in the Zipline, the user, while remaining calm, must remain stationary and not take any initiative and wait for the intervention of the staff.

10. The following are prohibited:

- using equipment and accessories that are not provided by the staff in charge;
- any tampering with, altering or even modifying the equipment and materials provided, including their adjustment;
- smoking;
- intentionally swinging or shaking cables and equipment;
- throwing objects of any type on the ground during air travel.

11. Zipline flying can generate intense emotions and is therefore strongly discouraged for anyone with health issues, such as, but not limited to, circulatory, cardiac or nervous system conditions, cases resulting from and/or related to injuries to the locomotor and/or bone system (e.g. spinal column).

12. Pregnant women are not permitted to use the service; therefore, any event occurring during or after the flight that has an impact on the state of pregnancy cannot be a source of liability in any way.

13. In order to access the itinerary, the following is recommended:

- wearing sportswear and athletic or hiking shoes;
- gathering up your hair;
- removing accessories that may become entangled (scarves, hoods, pendants, etc.) or fall (mobile phones, cameras, keys, etc.). Any video equipment has to be secured to the body and declared to staff for inspection.

14. In order to be admitted to the facility, it is necessary to be in good general physical condition, not to have heart problems, not to have ingested alcohol, drugs or medicines that may reduce normal abilities, and not to have physical or mental disabilities incompatible with flight safety.

15. The staff reserves the right, at its sole discretion, to deny access to the facility to anyone who does not provide sufficient guarantees of being able to access and descend in a safe and secure manner or who does not meet the necessary requirements. In this case, the ticket price is not refunded.

16. Users who misbehave or disregard the instructions of the staff, putting their own and other users' safety at risk, will be required to disembark and leave the facility and the area at the request of the staff. In this case, the ticket price is not refunded.

17. If there is bad weather, or, in any case, if it is judged necessary, the staff reserves the right to suspend access to the itineraries and/or to interrupt the execution of the service, with notification to be given in the form that is considered most appropriate at that time. If this is the case, users will be given the opportunity to reschedule the unfulfilled flight on another date.

18. If a user renounces and cancels his or her flight at the departure station (upslope), the ticket is not refunded.

19. With the purchase of the ticket, the user authorises the use of photos, videos, other communication tools and, in particular, the live transmission, publication and/or diffusion in any form of their images on websites, printed media and/or on any other means of circulation and to process their personal data without claiming any reimbursement of any kind and without requesting any form of compensation, without time limits, also in compliance with Articles 10 and 320 of the Italian Civil Code and Articles 96 and 97 of Italian Law dated 22.4.1941, number 633, the Copyright Law, as confirmed by Article 1, paragraph 1, of Italian Legislative Decree dated December 1 2009, number 179, and also authorises the storage of the photos and videos in computerised archives and acknowledges that the purpose of such publications is for information and communication purposes.
